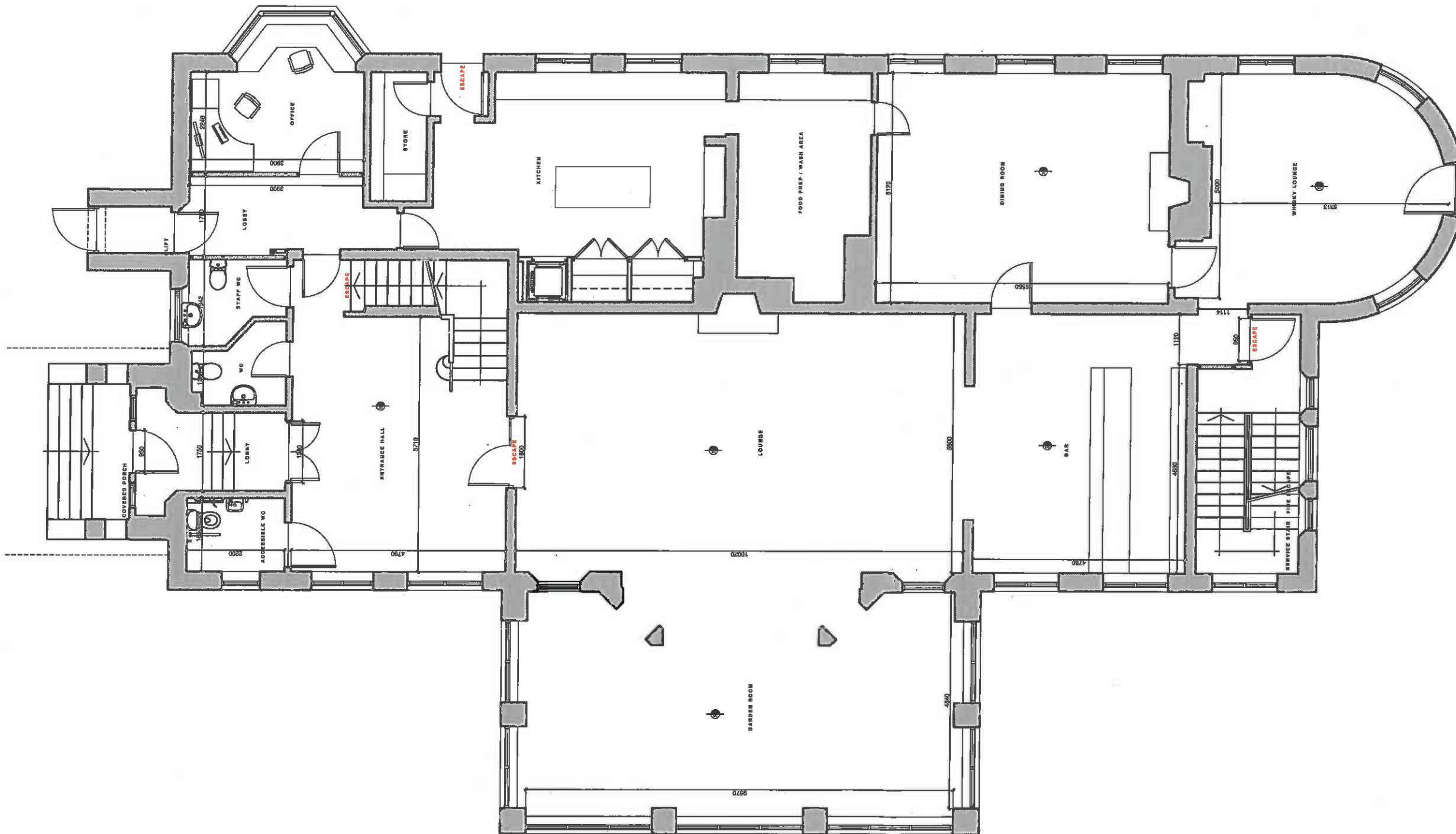

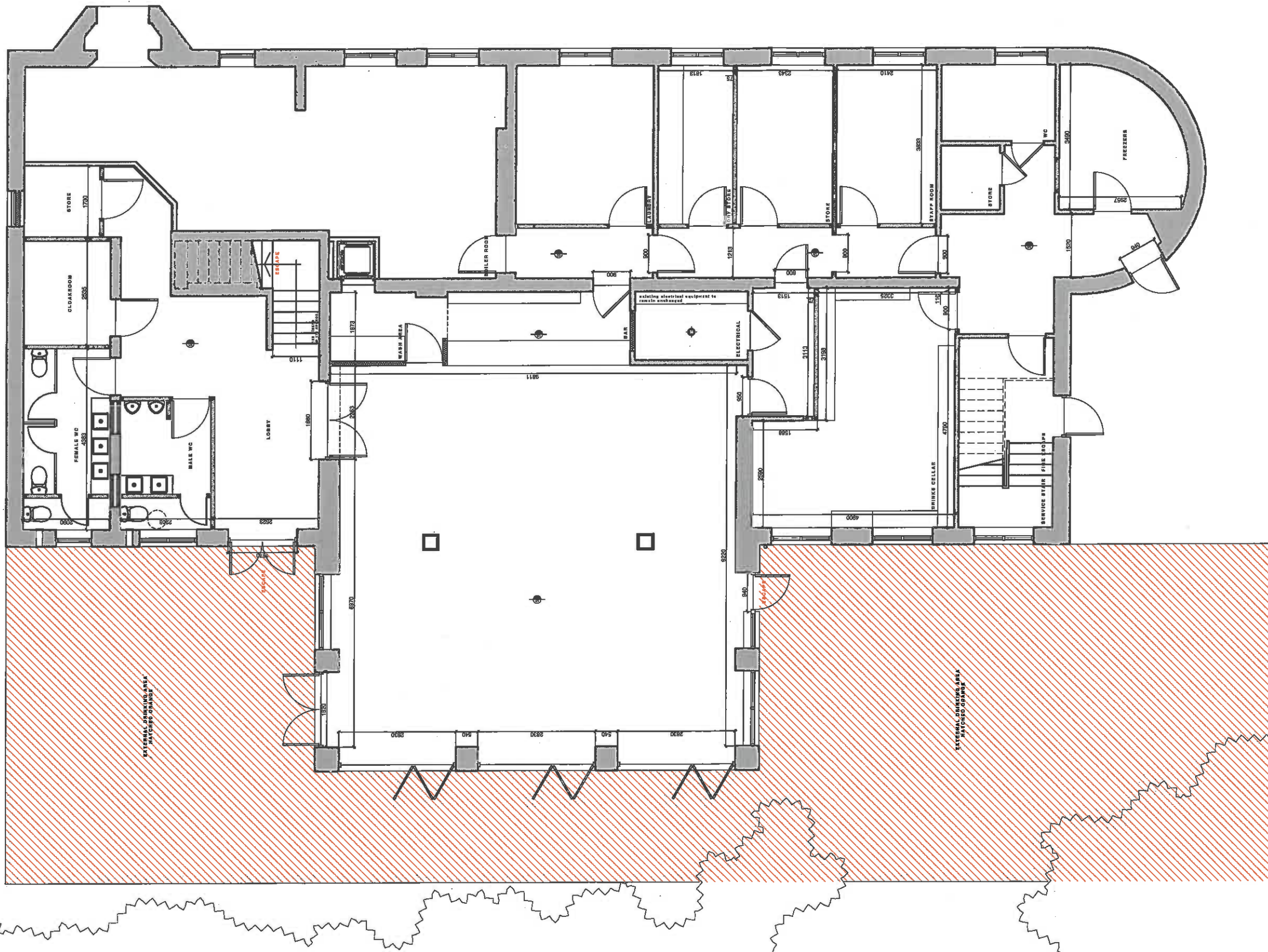

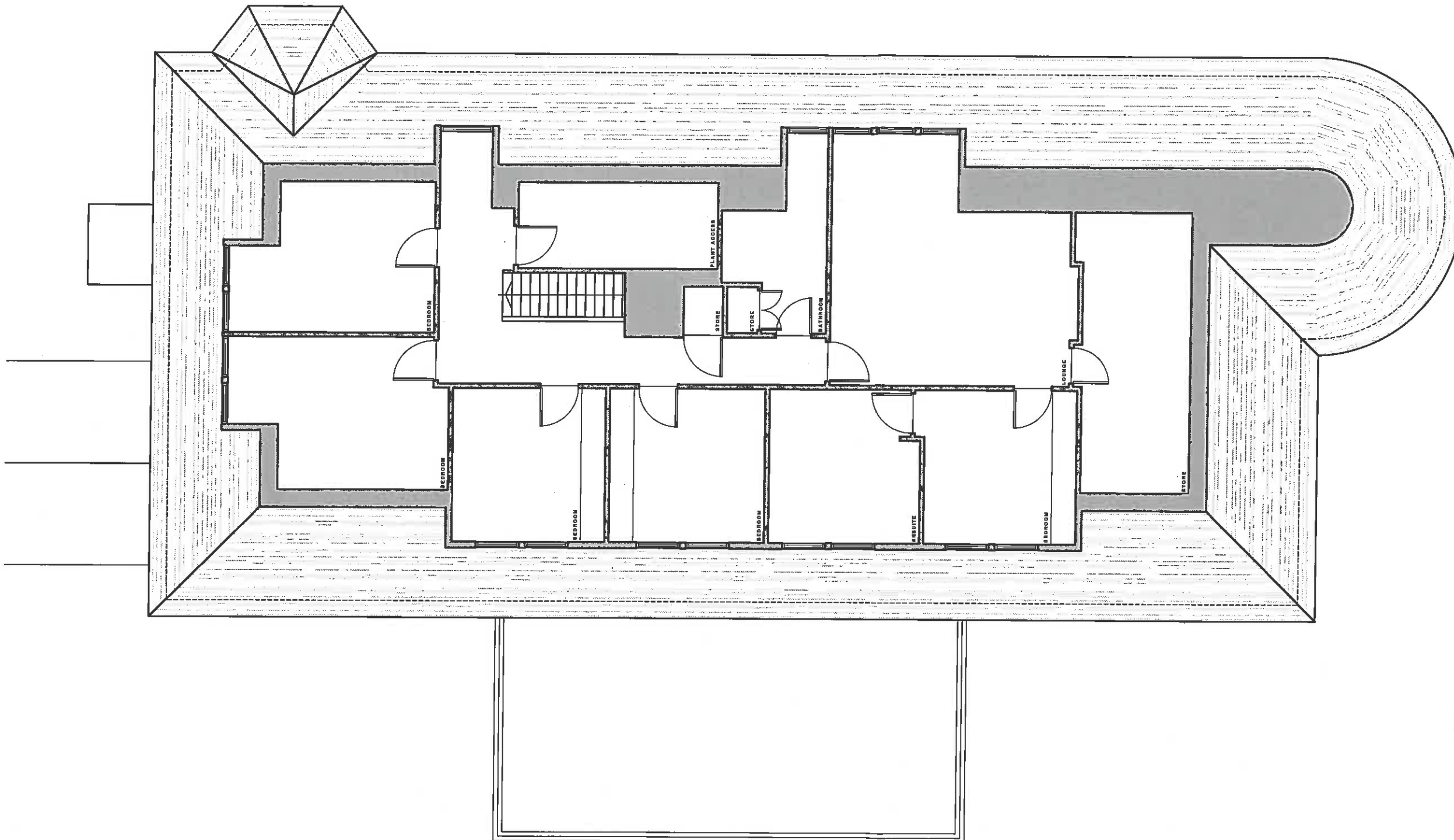
lower-ground floor plan

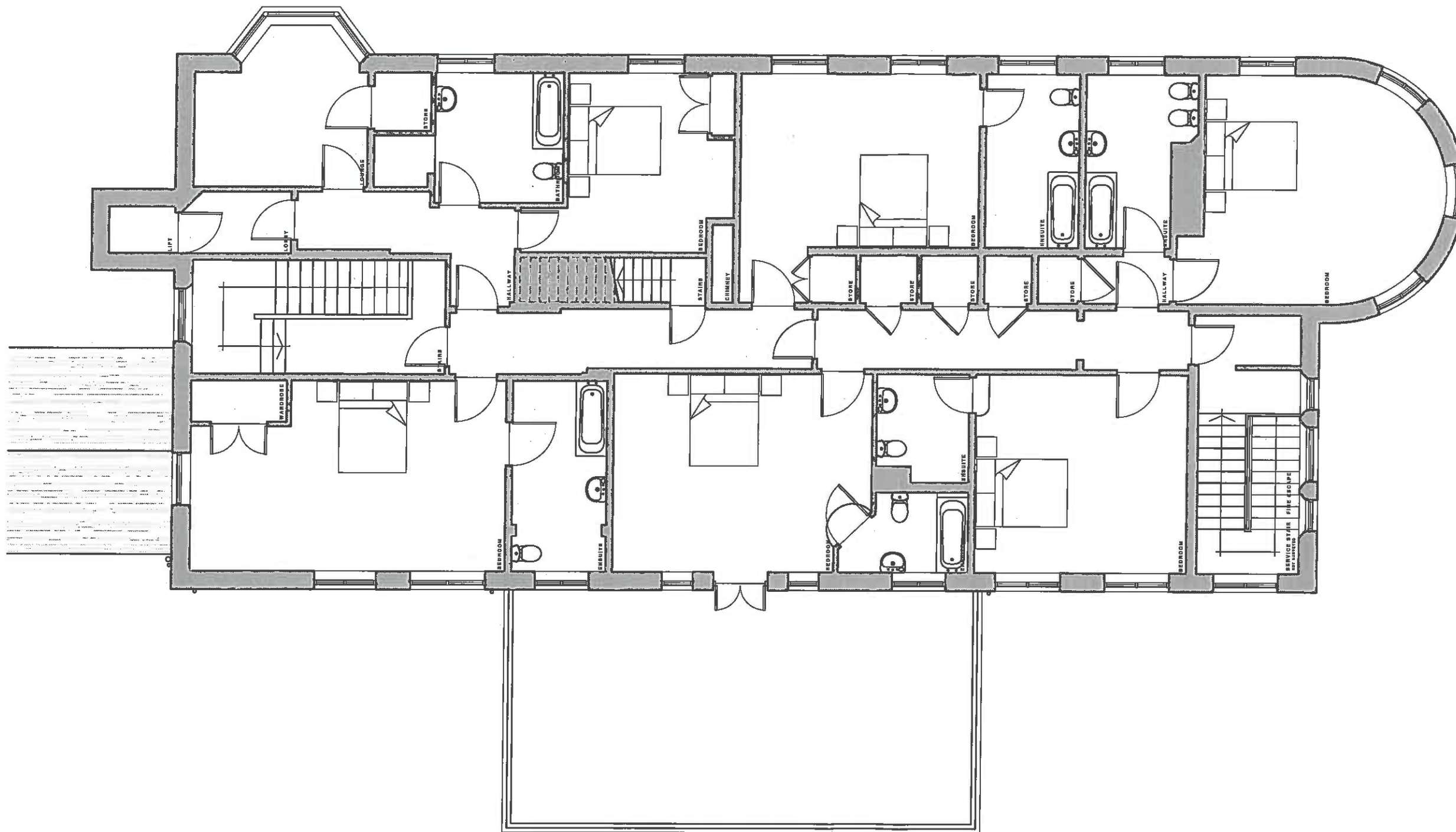
second floor plan

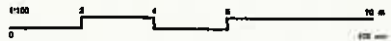

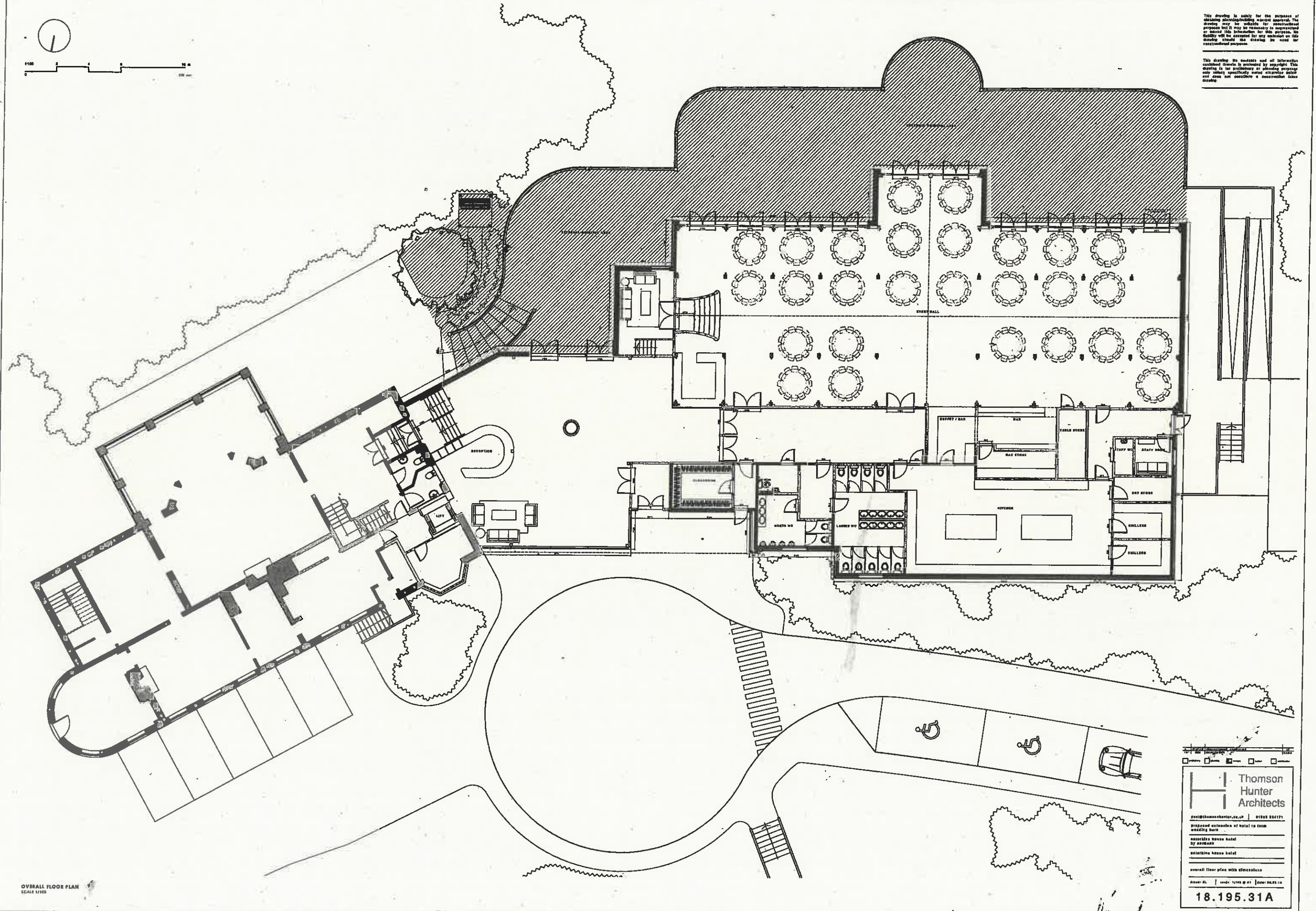
