THE BASIS OF ENTERTAINMENT AT THE COMPLEX IS GEARED AND DESIGNED AS FAMILY ENTERTAINMENT.

THE WRESTLING SHOW DESIGNED TO ENTERTAIN CHILDREN IS PROMOTED WITHIN THESE PREMISES. THIS TYPE OF CHILDREN'S AND FAMILY ENTERTAINMENT HAS BEEN AVAILABLE WITHIN THE PREMISES FOR MANY YEARS AND HAS NOT BEEN THE SUBJECT OF COMPLAINT OR CRITICISM AND IS VERY POPULAR AMONG GUESTS. THIS IS NOT PROFESSIONAL WRESTLING IN THE NORMAL SENSE AND IS GEARED PRIMARILY TO ENTERTAINMENT AND OFTEN THERE ARE CHARACTERS WHO WRESTLE AND THERE ARE SEVERAL SHORT BOUTS WHICH ARE DESIGNED TO APPEAL TO ALL SECTORS OF THE VISITING COMMUNITY.

THE PREMISES HAVE A BINGO LICENCE – TO ENABLE STRICT COMPLIANCE WITH THE LICENSING OBJECTIVES IT IS CONFIRMED THAT PROVISION OF JACKPOT MACHINES ARE SITED IN AN AREA WHICH IS RING-FENCED AND FROM WHICH CHILDREN ARE EXCLUDED UNTIL THE BINGO SESSIONS ARE COMPLETED. ALTERNATIVE CHILDREN'S ENTERTAINMENT

IS AVAILABLE WITHIN SEVERAL OF THE OTHER VENUES WITHIN THE COMPLEX. EXPERIENCE SHOWS THAT THE BULK OF PATRONS ATTENDING THE BINGO SESSIONS TEND TO BE GRANDPARENTS AND MOTHERS LEAVING OTHER RESPONSIBLE ADULTS IN THE COMPANY OF CHILDREN.
