The Lighthouse has a Grill Room which will be used as a halfway point for golfers wishing to obtain refreshments and use of facilities. The Lighthouse also have a self-contained accommodation suite on the second floor.

The applicant wishes to provide a refreshment buggy. The refreshment buggy will be stocked and leave from the Clubhouse to provide golfers with the option of refreshments consisting of alcoholic/non-alcoholic drinks, sandwiches and light snacks.

There is outside space which may be used to hold private functions/events and specially erected marquees will be used from time to time.

The golf academy and driving range may be used by golfers before/after their round of golf. There is a driving range including a simulator range. Golf lessons are available from the academy which also includes a shop. There are also golf simulators. There is no bar counter, it's more of a relaxed atmosphere and guests will be served drinks from cans of alcoholic and non-alcoholic drinks. Guest may leave the premises with alcohol which is decanted into a takeaway cup (if required) and can also sit outside the premises.
